Sealed quotation in two bid system affixing non-refundable court fees Stamp of Rs. 8.25 (Rupees eight and paisa twenty five) only are invited from the reputed manufacturers /Authorized Dealers /authorized distributors, for supply of Consumables- Disposables in Assam State AIDS Control Society, Khanapara, Guwahati-22. The quotation must reach the undersigned on or before 26/11/2018 up to 1:30 P.M. after which no quotation will be accepted. The quotation will be opened on the same day at 2:00 P.M. in presence of the bidders or their authorized representatives, if any. No Complaint will be entertained and considered on the plea of postal delay or otherwise and also no correspondence will be made or entertained regarding noncompliance of any terms and conditions and submission of documents along with the quotations as required. An EMD @ 2% of the cost of quoted items is required to submit along with the tender. Submission of samples of quoted items is a must. The tender is valid for 90 (Ninety) days. Quantum of items may be increased or decreased subject to the availability of fund.

TECHNICAL BID "COVER 'A"

The bidder shall furnish along with the bid, the following, in a separate cover, hereinafter called **Cover** 'A'

- a) All bids must be accompanied with **EARNEST MONEY DEPOSIT** @ 2% of the cost of quoted items in the form of Demand Draft/Bankers Cheque in favour of the Project Director, Assam State AIDS Control Society, payable at Guwahati. EMD of the successful bidder shall be retained till completion of the contract but shall not carry any interest. In case the successful bidder fails to execute the contract and/ or withdraws the bid within the validity period of the bid, the EMD shall be forfeited. The EMD of the unsuccessful bidders will be returned after finalization of the tender.
- b) Copy of valid manufacturing license, where applicable.
- c) Annual Turn Over Statement along with income tax acknowledgement receipt for last 3 financial years i.e. 2014 2015, 2015 2016, 2016 2017 certified by the Auditor / Chartered Accountant.
- d) Authorization like Power of Attorney or Resolution of the Board for the officer of the company who has signed the tender document and the bid.
- e) GST Registration Certificate.
- f) Up to date Trade License.
- g) PAN Card and Bank A/C.
- h) Up to date valid Drug License.
- i) ISO/ WHO GMP or other quality assurance certificate from competent authority.
- j) The bidder is required to submit two sets of sealed sample of each batch. The samples may be sent for External Quality Assurance for further confirmation. Price bid will be open for only those samples which qualified in the said test.

2. PRICE BID "COVER 'B"

a) Bidder should submit the quotation as per below mentioned format. Correction, if any, shall be made by crossing out, initialing, dating and rewriting failing which the bid shall be considered ineligible for evaluation.

- b) The All duties, taxes and other levies payable by the bidder under the contract shall be included in the total price. The rate quoted per unit shall be the landed cost inclusive of packing, forwarding, Excise Duty, GST, Freight, Insurance, showing the break up of cost for taxes and duties.
- c) Each page of the price bid shall be duly signed by the bidder with official seal.
- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to change/ modification on any account.
- e) The prices shall be quoted in Indian Rupee only.

- 3. The Cover 'A' and Cover 'B' shall be separately sealed and both the covers shall be put in another sealed cover super scribed as "TENDER FOR SUPPLY OF MEDICAL REAGENTS TO ASSAM SACS (TENDER No. TENDER No. ASACS/NACP-IV/Proc/SS/2018/1093; Dated:01/11/2018) & ADDRESSED TO "THE PROJECT DIRECTOR, ASSAM STATE AIDS CONTROL SOCIETY, KHANAPARA, GUWAHATI 22".
- **4.** Cover 'A' i.e. Technical-Bid shall be opened at the office of the purchaser intimated earlier, on the date and time specified in presence of the intending bidders or their authorized representatives.
- 5. Cover 'B' i.e. the Price- Bid of the bidders who meet the eligibility criteria and samples qualified in the external quality assurance test, evaluated based on the details furnished in Cover 'A' shall only be opened and the date and time of opening of Cover 'B' shall be intimated to the eligible / short listed bidders.

4. VALIDITY OF QUOTATION

Quotation shall remain valid for a period of 90 days after the deadline date specified for submission of quotation.

VALIDITY OF RATES

The rate will be initially valid for 1 (one) year from the date of signing agreement. The validity of rates may further be extended with mutual consent. However, the Tendering Authority reserves the right to reduce/ cancel the validity period.

5. EARNEST MONEY DEPOSIT

All bids must be accompanied with **EARNEST MONEY DEPOSIT** @ 2% of the cost of quoted items in the form of Demand Draft/Bankers Cheque in favour of the Project Director, Assam State AIDS Control Society, payable at Guwahati. EMD of the successful bidder shall be retained till completion of the contract but shall not carry any interest. In case the successful bidder fails to execute the contract and/ or withdraws the bid within the validity period of the bid, the EMD shall be forfeited. The EMD of the unsuccessful bidders will be returned after finalization of the tender.

6. PERFORMANCE SECURITY DEPOSIT:

The successful bidder shall be required to submit Performance Security Deposit @ 4% of the order value. The Performance Security Deposit shall be released on completion of the validity of the tender. However, if the supplied materials get consumed earlier than this stipulated period, the Security Deposit will be released immediately.

7. ANNULMENT OF AWARD, FORFEITURE OF SECURITY DEPOSIT & FRESH AWARD

Failure of the successful bidder to comply with the requirements shall constitute sufficient grounds for annulment of the award and forfeiture of the bid security.

Under such situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstance.

8. <u>DELAY IN DELIVERY</u>

- a) In case there is delay in delivery beyond the stipulated period, there shall be reduction in price @
 0.5% of the value of delayed goods per week of delay or part thereof subject to a maximum of 10% of the total order value.
- b) Once the maximum price reduction is reached, termination of the contract may be considered.
- c) Non-performance of the contract provisions shall make the successful bidder liable to be disqualified to participate in any tender for the next 5 years, in addition to forfeiture of EMD and other penal provisions.

9. EVALUATION OF QUOTATIONS

The tender will be evaluated under QCBS system. 60% weightage will be given to the marks from quality testing of samples by technical committee and 40% weightage will be given to price.

The bidder to quote the lowest rate (L1) may not be the successful bidder if he fails to fulfill the technical/ specifications criteria. Bidder(s) to fulfill all technical/ specifications and sample criteria shall only be recommended for Price Bid Evaluation.

10. AWARDS OF CONTRACT

The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who will be qualified to be the lowest evaluated bidder.

Notwithstanding the above, the purchaser reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

The bidder whose bid is accepted will be notified of the award of the contract by the purchaser prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

11. PAYMENT TERMS:

No advance payment shall be made. The paying authority on production of the following documents shall make payment:-

- a) The Challan Copy.
- b) Invoice in triplicate.
- c) On receipt of the above documents the paying authority shall make payment to the supplier after deduction of taxes as applicable.

12. SAVING CLAUSE:-

No suit, prosecution or any legal proceedings shall lie against Tender Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of tender

13. Project Director, Assam State AIDS Control Society, reserves the right to accept or reject any or whole of the Tender without assigning any reason there of and does not bind himself to accept the lowest or any other rates. The decision of the Project Director, Assam State AIDS Control Society, will be binding and final in all cases.
