**Call for Expression of Interest (EOI) from Chartered Accountant Firms for Statutory
Audit of Assam State Aids Control Society**

The Assam State AIDS Control Society is a registered society under the Societies Registration Act, 1860 which receives fund from Govt. of India under Domestic Budgetary Support for implementation of National AIDS Control Programs (NACP) in the State of Assam. ASACS releases fund to peripheral organizations and hospitals under government sector and NGOs. Hence it is essential as to conduct a statutory audit of the Society under the provision of the Societies Registration Act, 1860.

Expression of Interest are invited from CAG empanelled Chartered Accountant firms to conduct the Statutory Audit of Assam State AIDS Control Society for the Financial Year 2023-24 and submit the Income Tax Return of Assam State AIDS Control Society.

Eligibility & Assessment Criteria:

The EOI and capability will be assessed against evidence of skills and experience in providing accountancy services in the State.

Requirements:

The EOI should be sent along with a Capability Statement including a profile of the organization relevant technical and geographical coverage along with the financial turnover for the last 3 financial years. (A format for the Capability statement in Annexure – IX(b) is available in the ASACS website: <https://asacs.assam.gov.in> and <https://sppp.assam.gov.in/#/en>) or may be obtained from ASACS Office during office hour. Individual CVs are not required at this stage. Any EOI with inadequate information, those which do not meet the above criteria, or those received after the closing date will not be short listed. EOI should be as concise and focused as possible to give evidence of the above requirements including the capability statement and organization profiles. They should be mailed to the Project Director, Assam State AIDS Control Society, Khanapara, Guwahati-781022 to arrive not later than 3 p.m. on 19th March, 2024. Only organizations, which pass the pre-selection process, will be contacted and invited to submit detailed proposals.
